Frank Vitrano is the Associate Director for the 2020 Census at the U.S. Census Bureau. He currently provides executive leadership and overall direction for the American Community Survey and for early planning for the 2020 Census. From September 2005 through June 2011, Frank was the Chief of the Decennial Management Division at the U.S. Census Bureau. In that position, he coordinated the overall program management for the 2010 Census. This included managing the scope, schedule, and budget for the program. Frank began his career at the Census Bureau in 1984 in the Demographic Statistical Methods Division where he primarily worked on the implementation of frame development and sample selection for the Consumer Expenditure Surveys, the American Housing Surveys, and the School and Staffing Surveys. In September 2008, David Winter became the Director of the Office of Highway Policy Information within the Federal Highway Administration's Office of Policy and Governmental Affairs. In this capacity, he is responsible for overseeing the staff responsible for collecting, analyzing, and reporting much of the data used for apportioning Highway Trust Funds; determining agency performance measures; and estimating current and future highway needs. In January 2009, David also assumed responsibility for the reporting and analysis of all FHWA related American Recovery and Reinvestment Act data. From July 2004 to September 2008, David served as the Chief of the Highway System Performance Division.
